WHEREAS, the Orleans Parish School Board determines that unanticipated changes in the level of services needed to support students constitutes an exceptional circumstances that justifies the use of the School Board's general fund balance reserve.

NOW, THEREFORE, BE IT RESOLVED that the Orleans Parish School Board hereby authorizes the allocation of \$465,448.00 from the general fund balance reserve to the FY 2017-2018 general fund budget for the purpose of funding direct investments in student learning priorities at McDonogh 35 Senior High School.
