WHEREAS, in a decentralized school system, schools must leverage partnerships with organizations and service providers to provide direct services to students and families that a traditional centralized school district would otherwise offer; and

WHEREAS, recognizing that schools need its support in advancing student achievement, the School Board has established partnerships with non-profit agencies that are positioned to meet key service needs of students in New Orleans public schools; and

WHEREAS, the School Board desires to strengthen its support of schools, as the school district unifies, by identifying gaps in services currently being provided to students and by facilitating the engagement of a diverse pool of qualified partner organizations to best serve the various needs of students and families; and

WHEREAS, a group of local philanthropists, under the coordination of the Greater New Orleans Foundation, is offering consulting support services to the School Board's administration to assist in the development of a strategic plan for identifying and working with qualified partner organizations.

NOW, THEREFORE, BE IT RESOLVED, that the Orleans Parish School Board supports the development of a strategic plan for identifying and working with partner organizations to best serve the needs of students and families in a unified school district; and

BE IT FURTHER RESOLVED that the School Board hereby accepts the offer of assistance from philanthropists, under the coordination of the Greater New Orleans Foundation, with retaining consultants to develop the strategic plan and empowers its Superintendent and administration to engage with the group of local philanthropists to select the consultants and to

apply the recommend strategic plan in managing partnership work moving forward as a unified school district.
