

**ORLEANS PARISH SCHOOL BOARD
RESOLUTION NO. 13-17**

The following resolution was offered by Sarah Newell Usdin and seconded by Woody Koppel:

A resolution authorizing the Orleans Parish School Board, in connection with the construction of the new Booker T. Washington High School, to accept the transfer of Clio Street (from Roman Street to Prieur Street) from the City of New Orleans to the Orleans Parish School Board, and, authorizing the resubdivision of the entire tract of immovable property designated for the construction of the new Booker T. Washington High School.

WHEREAS, on or about September 12, 1939, the Council of the City of New Orleans passed City Council Ordinance No. 14945 decreeing, "in order to build a Negro High School and Auditorium for the Orleans Parish School Board and directing the Mayor of the City of New Orleans to close to public use and transfer for the use of the Orleans Parish School Board Clio Street between the River Property Line of Prieur Street and the Lake Property Line of Roman Street"; and

WHEREAS, said transfer of Clio Street from the City of New Orleans to the Orleans Parish School Board was never formally accepted and recorded in the public records of the Land Records Division, Clerk of Civil District Court for Orleans Parish; and

WHEREAS, once said transfer is recorded in the public records of the Land Records Division there is the necessity for a resubdivision of the entire tract of immovable property designated for the construction of the new Booker T. Washington High School, more fully described in Exhibit "A".

NOW THEREFORE, BE IT RESOLVED, that the Orleans Parish School Board hereby accepts the transfer of Clio Street (from Roman Street to Prieur Street) by the City of New Orleans to the Orleans Parish School Board in accordance with the September 12, 1939, City Council Ordinance No. 14945.

AND BE IT FURTHER RESOLVED, that the Orleans Parish School Board hereby authorizes the Superintendent and/or his designee to perform any and all ministerial or administrative acts necessary to accomplish said transfer and subsequent resubdivision of the entire tract of immovable property designated for the construction of the new Booker T. Washington High School, more fully described on Exhibit "A"




